Biography

Professor Hugh Koch is a clinical psychologist, Director of a medico-legal firm, (Hugh Koch Associates) and a visiting Professor to the School of Law, Birmingham City University. His main professional interest is in the multidisciplinary interface between Science, Psychology and Law in the Civil Court, where he now has unique experience and publication record. In general, he is committed to “giving psychology away” to others.

As a clinical psychologist, he has worked in the NHS between 1973 and 1986, achieving the highest top grade in Colchester in 1985. During this time he worked as a clinician in adult mental health settings (hospital, GP surgeries, community teams). He lectured in Charlotte, North Carolina (USA) between 1981 and 1986 as a visiting Professor of psychology, and in Hong Kong (1991-2).

Between 1986 and 1990, he worked as a senior unit NHS General Manager in Somerset (Mental Health Services) implementing a £10m community care programme and Cheltenham (General Medical Services) managing 5 acute hospitals and a budget of £30m.

In 1990, he worked as a public sector management consultant in Total Quality Management and developed innovative and unique TQM programmes in several NHS facilities and published six seminal books on these practices.

In 1991, he established Hugh Koch Associates, a unique medico-legal firm providing psychological and orthopaedic reporting services to the civil courts. This now comprises 55 clinical psychologists and 1 orthopaedic surgeon providing 150 clinics and services in 105 cities and towns in the UK.

Since 1991, Hugh has published extensively in law journals on issues relating to ‘Psychology and Law’ and has lectured widely on this topic. In

2015, he was invited to be a visiting professor to the School of Law, University of Stockholm. In 2017 & 2018, he lectured to the Forensic Psychology students at Birmingham City University on ‘Reliability and Truthfulness in Civil Litigation’ and contributes to its Centre for Law, Science & Policy, where he is now Visiting Professor in Psychology & Law.

He has collaborated with Law and Psychology colleagues in Europe (Sweden, Holland), Asia (Russia), USA (California, Pennsylvania, North Carolina), and Canada (Toronto). He is 71 years old (D.O.B. 14.03.51), married with two children (31, 38), and two grandchildren, and lives in Cheltenham.

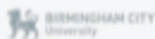

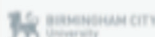
